I agree that that I have been informed of the limitation on liability contained in the Massachusetts General Laws of Section 2D of Chapter 128 also contained on the back page of this entry form.

WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

Under Massachusetts law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 2D of chapter 128 of the General Laws.

Persons signing below and on the facing page indicate by such signing that they freely and voluntarily sign this waiver of liability, assumption of risk, and indemnification agreement, with understanding of the legal rights that they hereby agree to and release. Further, they acknowledge being advised of the general law of Massachusetts concerning the above notice, which references the inherent risks involved in riding and working around horses, which risks include bodily injury from using, riding, or being in close proximity to horses, among other risks, and further, that both horse and rider will be injured in normal use or in competition and schooling.

The inherent risks of equine activities, dangers, or conditions which are an integral part of equine activities, include but are not limited to:

- (1) The propensity of **equines** to behave in ways that may result in injury, harm, or death to persons on or around them;
- (2) the unpredictability of an **equine's** reaction to such things as sounds, sudden movement, and unfamiliar objects, persons, or other animals;
- (3) certain hazards such as surface and subsurface conditions;
- (4) collisions with other **equines** or objects;
- (5) the potential of a participant to act in a **negligent manner** that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his ability.

In consideration, therefore, for the privilege of riding and or working around horses on the premises and at other premises while under the direction of the agents and employees of Wild Aire Farm LLC, the signatories agree to hold harmless and indemnify Wild Aire Farm LLC, the DiGregorio family, and their agents, employees, representatives, and assigns and further release them from any liability or responsibility for accident, damage injury, or illness to the undersigned or any horse owned by the undersigned, or to any family member, leasee, or spectator accompanying the undersigned on the premises. Further, this hold harmless and indemnification agreement does include **all costs of suit and attorneys fees associated with the defense of any claims made or actions filed.**

Further, the signatories agree that they fully understand and are aware that Wild Aire Farm LLC operates an establishment that caters to horses which are involved in the sport of show jumping, and that the jumping of horses is a risky pursuit that carries with it the dangers of serious bodily injury up to and including paralysis and death. The undersigned hereby assumes all risks associated with the riding, showing, grooming, and/or observation as a spectator on the premises of Wild Aire Farm LLC or at other farms or locations under the direction of agents or employees of Wild Aire Farm LLC, the DiGregorio family, and while showing at the Horse Power Horse Shows.
